Be it further RESOLVED that UMass Amherst will submit the above-referenced strategic plan in sufficient time for review, discussion and appropriate action by the Board of Trustees and its subcommittees.

The University and its vendors shall comply with all federal and state laws and regulations as well as University policies, procedures and guidelines relative to the confidentiality and privacy of University employees and students. All University employees are required to provide continuing assurances and be fully aware that any conflict of interest related to or appearance of a conflict with a vendor is unacceptable. The President of the University shall issue guidelines to implement this University policy.

And further, That each Authorized Officer is hereby authorized to do all other things and to take all other action deemed necessary or desirable to carry into effect the matters hereby authorized, including without limitation the execution, sealing and delivery on behalf of The Commonwealth of Massachusetts (the “Commonwealth”), the Trustees or the University, of contracts for state financial assistance in the form of a guaranty by the Commonwealth of the Refunding Bonds of the Authority or for management and services with respect to projects refinanced by the Refunding Bonds (all as provided in and subject to the Enabling Act), each such contract to have such provisions as are approved by the signer thereof on behalf of the Commonwealth, the Trustees or the University.

And further, That this vote shall take effect immediately upon passage.
